The board (the "**Board**") of directors (the "**Directors**") of the Company wishes to inform the shareholders of the Company (the "**Shareholders**") and potential investors that, based on a preliminary review of the unaudited consolidated management accounts of the Group for the six months ended 30 September 2023 and the information currently made available to the Board, the Group is expected to record a consolidated net loss not more than HK\$1.9 million for the six months ended 30 September 2023 as compared to an unaudited consolidated net profit of approximately HK\$4.3 million for the corresponding period in 2022.

The expected turnaround from profit to loss in the current period was primarily attributable to (i) non-cash item resulted from the fair value change (loss) of investment properties of approximately HK\$3.4 million; (ii) decrease in revenue and gross profit which resulted from the substantial completion of the projects on hand during the six months ended 30 September 2023; and (iii) decrease in other income which mainly involve one-off government grants received from the Hong Kong government for the corresponding period in 2022.

The Company is still in the process of preparing the interim results of the Group for the six months ended 30 September 2023. The information contained in this announcement is based on the preliminary assessment made by the Board with reference to the information currently available and the unaudited consolidated management accounts of the Group for the six months ended 30 September 2023, which have not been audited or reviewed by the Company's auditor or the audit committee of the Board and may be subject to adjustment.
