- (1) to access all future Corporate Communications through the Company's website at <a href="www.johnsonelectric.com">www.johnsonelectric.com</a> instead of receiving printed copies and to receive a notification letter of the publication of the Corporate Communications on the Company's website ("Website Version"); or
- (2) to receive printed English version of all future Corporate Communications only; or

- (4) to receive both printed English and Chinese versions of all future Corporate Communications.
