**Report on Production and Sales Volume of Dongfeng Motor Group for November at 2023**

This is a voluntary announcement made by Dongfeng Motor Group Company Limited (the "Company").

The Company's sales volume in the first eleven months of 2023 was 1,916,527 units, representing a decrease of 14.9% year-on-year. Dongfeng Motor Company, the parent company of the Company, recorded a total sale of 2,184,297 vehicles for the first eleven months, representing a decrease of 18.2% year-on-year. The sales volume of Dongfeng Automobile Company Limited (A-share code 600006, hereinafter referred to as "DFAC"), a subsidiary of the Company, was 141,530 units for the first eleven months, representing a growth of 17.4% year-on-year.
