1(B).	To extend the general mandate granted to the directors to issue shares of the Company, by ways of adding the number of shares equal to the number of shares repurchased by the Company pursuant to the repurchase mandate passed on the 2022 AGM.

Your proxy will also be entitled to vote at his discretion on any resolution properly put to the meeting other than those referred to in the Notice of EGM.

This form of proxy must be signed by you or your attorney duly authorized in writing or, in the case of a corporation, under its common seal or under the hand of an officer or attorney duly authorized. To be valid, this form of proxy together with any power of attorney or other authority (if any) under which it is signed or notarially certified copy of such power or authority must be deposited at the Hong Kong share registrar of the Company, Computershare Hong Kong Investor Services Limited, at 17M Floor, Hopewell Centre, 183 Queen’s Road East, Wanchai, Hong Kong not less than 48 hours before the time for holding EGM or any adjournment thereof. Completion and return of this form of proxy will not preclude you from attending and voting in person at the EGM. In the event that you attend the EGM, this form of proxy will be deemed to be revoked.
7. In the case of joint holders of any shares, any one of such joint holders may vote at the EGM, either personally or by proxy, in respect of such shares as if he were solely entitled thereto. If more than one of the joint holders are present at the EGM, either personally or by proxy, that one of the said persons whose name stands first on the register of members in respect of the relevant share(s) will alone be entitled to vote in respect of the relevant joint holding.
8. On a poll, every shareholder present personally or by proxy shall be entitled to one vote for each share registered in his name. The result of such poll shall be deemed to be the resolution of the EGM at which the poll was so taken.
9. **ANY ALTERATIONS MADE IN THIS FORM SHOULD BE INITIALED BY THE PERSON WHO SIGNS IT.**
