## **ANNOUNCEMENT POWER GENERATION FOR NOVEMBER 2023**

This announcement is made pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited and Inside Information Provisions under Part XIVA of the Securities and Futures Ordinance (Cap. 571, Laws of Hong Kong).

The board of directors (the “**Board**”) of China Longyuan Power Group Corporation Limited\* (the “**Company**”) announces that, according to the Company’s preliminary statistics, the power generation of the Company and its subsidiaries (the “**Group**”) for November 2023 on a consolidated basis amounted to 7,531,024 MWh, representing a year-on-year increase of 24.93% as compared with the corresponding period of 2022. In particular, the wind power generation registered an increase of 22.73%, the coal-fired power generation registered an increase of 2.67%, and other renewable energy power generation registered an increase of 283.04%. As of 30 November 2023, the total power generation of the Group for 2023 amounted to 68,484,835 MWh, representing a year-on-year increase of 7.67% as compared with the corresponding period of 2022. In particular, the wind power generation registered an increase of 5.19%, the coal-fired power generation registered a decrease of 2.57%, and other renewable energy power generation registered an increase of 149.34%.
