Announcement Trading Update Power Generation For November 2023

This announcement is made by CGN New Energy Holdings Co., Ltd. (the "Company") on a voluntary basis.

The board (the "Board") of directors (the "Directors") of the Company announces that, according to the preliminary statistics of the Company, the power generation of the Company and its subsidiaries (the "Group") on a consolidated basis amounted to 1,660.1GWh for the month of November 2023, representing an increase of 0.7% compared with the corresponding period of 2022. In particular, power generation of PRC wind projects increased by 30.7%, power generation of PRC solar projects increased by 10.5%, power generation of PRC cogen and gas-fired projects increased by 25.2%, power generation of PRC hydro projects decreased by 27.0% and power generation of Korea projects decreased by 34.0%. For the eleven months ended 30 November 2023, the accumulated power generation of the Group of this year amounted to 17,381.1GWh, representing a decrease of 0.1% compared with the corresponding period of 2022. In particular, power generation of PRC wind projects increased by 10.7%, power generation of PRC solar projects increased by 1.6%, power generation of PRC cogen and gas-fired projects increased by 4.7%, power generation of PRC hydro projects decreased by 54.5% and power generation of Korea projects decreased by 10.8%.

A cogen project located in Jiangsu Province, the PRC increased its dispatch capacity compared to the same period last year, resulting in a year-on-year increase in power generation in November 2023.

A hydro project located in Sichuan Province, the PRC experienced a significant decrease in water inflows in November 2023 compared to the same period last year, resulting in a year-on-year decrease in power generation in November 2023.

The Yulchon Gas-fired Project in Korea experienced a year-on-year decrease in electricity generation in November 2023 as a result of the decrease in the load of power grid dispatch due to the local limits of on-grid in November 2023.
