PROPOSED ADOPTION OF NEW BYE-LAWS

A circular containing, among other things, particulars relating to the proposed amendments to the Existing Bye-laws with a notice convening the AGM will be despatched to the Shareholders together with the annual report for the year ended 31 December 2022 in due

course.
