# THE FINANCE LEASE AGREEMENTS

The principal terms of the Finance Lease Agreements are as follows:

# **Parties**

Lessor: the Company

Lessee: a limited company incorporated in the PRC, which is principally engaged in energy

conservation and emission reduction business.

To the best of the Directors' knowledge, information and belief after having made all reasonable enquiries, the Lessee and their ultimate beneficial owner are all independent third parties to the Company and its connected persons (as defined in the Listing Rules).

#### **Leased Assets**

The Leased Asset I is a patented technology for utilizing slag waste heat and serving energy conservation and emission reduction related businesses, with a net book value of approximately RMB8,580,000.

The Leased Assets II are energy management related equipment, with a net book value of approximately RMB30,659,769.94.

The Leased Assets III are high-pressure roller mills, with a net book value of approximately RMB20,443,171.55.

The Lessee does not separately calculate the profits before and after tax of the Leased Assets. The transfer consideration for the acquisition of the Leased Assets under the Finance Lease Agreements will be funded by the Company's internal resources.
