- (i) all money due to the listed issuer in respect of the issue of securities has been settled in accordance with the terms of the Post-IPO Share Option Scheme II and 2023 Share Option Scheme.  
Remark: In relation to the issue of 61,371 shares at the issue price of HK\$185.65 per share, as part of the arrangement to settle the exercise price in a cashless manner, the option holder exercised 150,000 share options under Post-IPO Share Option Scheme II on 20 December 2023. The automatic deduction of 88,629 shares represents the consideration payable for the exercise of 150,000 share options (such that 61,371 shares were issued after the netting off). The issue of the remaining 107,712 shares relates to the exercise of 107,712 share options under Post-IPO Share Option Scheme II and 2023 Share Option Scheme and has been settled in cash;
- (ii) all the securities of each class are in all respects identical (Note 10); and
- (iii) all the definitive documents of title have been delivered/are ready to be delivered/are being prepared and will be delivered in accordance with the terms of issue.
