AMENDMENTS TO THE ARTICLES OF ASSOCIATION

This announcement is made pursuant to Rule 13.51(1) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited.

Reference is made to the announcement of Guoquan Food (Shanghai) Co., Ltd. (the “**Company**”) dated November 27, 2023 (the “**Announcement**”) in relation to the partial exercise of the over-allotment option in respect of an aggregate of 8,557,600 H Shares. Unless the context otherwise requires, terms used herein shall have the same meanings as those defined in the Announcement.

Upon partial exercise of the over-allotment option, the registered capital and total number of the shares of the Company were changed to RMB2,747,360,400 and 2,747,360,400 shares, respectively. To reflect such changes in the registered capital and share capital structure of the Company, corresponding amendments were made to the articles of association of the Company (the “**Articles of Association**”).

In accordance with the resolutions passed at the 2023 second extraordinary general meeting held on March 26, 2023, the general meeting of the Company has authorized the board of directors of the Company (the “**Board**”) and persons authorized by the Board to make corresponding adjustments and amendments to the Articles of Association of the Company relating to the contents of the registered capital and the share capital structure in accordance with the actual circumstances of the issuance and listing of the Company upon completion of this issuance and listing.

The industrial and commercial registration, filing and other matters in respect of the above amendments to the Articles of Association will be completed with the relevant government or regulatory authorities in the PRC.
