POLL RESULTS OF SPECIAL GENERAL MEETING HELD ON 28 DECEMBER 2023

Reference is made to the notice of the special general meeting (the “**SGM**”) of COSCO SHIPPING International (Hong Kong) Co., Ltd. (the “**Company**”) dated 6 December 2023 (the “**SGM Notice**”) and the circular of the Company dated 6 December 2023 (the “**Circular**”). All capitalised terms used herein shall have the same meanings as those defined in the SGM Notice and the Circular unless otherwise stated.

The Board is pleased to announce that at the SGM, the proposed resolution as set out in the SGM Notice was duly passed by the Independent Shareholders by way of poll.

The Company’s branch share registrar and transfer office in Hong Kong, Tricor Abacus Limited, was appointed as scrutineer for the vote-taking at the SGM. As at the date of the SGM, the total number of issued Shares was 1,465,971,429 Shares. As stated in the Circular, in view of the interests of COSCO SHIPPING and COSCO SHIPPING (Hong Kong) in the Company, COSCO SHIPPING, COSCO SHIPPING (Hong Kong) and their respective associates were required under the Listing Rules to abstain and had so abstained from voting on the resolution proposed at the SGM. Accordingly, the number of Shares of holder(s) that was/were required under the Listing Rules to abstain from voting was 1,051,183,486 Shares, which were held by COSCO SHIPPING (Hong Kong) as at the time of the SGM, representing approximately 71.70% of the total number of issued Shares, and the total number of Shares entitling the Independent Shareholders to attend and vote for or against the resolution proposed at the SGM was 414,787,943 Shares, representing approximately 28.30% of the total number of issued Shares. Save as disclosed above, there was no Share entitling the Shareholders to attend and abstain from voting in favour of the resolution proposed at the SGM as set out in Rule 13.40 of the Listing Rules and no Shareholder was required under the Listing Rules to abstain from voting at the SGM. Except COSCO SHIPPING, COSCO SHIPPING (Hong Kong) and their respective associates, none of the Shareholders has stated their intention in the Circular to vote against or to abstain from voting on the resolution proposed at the SGM.

The poll results in respect of the resolution passed at the SGM were as follows:

As a majority of the votes were cast in favour of the resolution as set out in the SGM Notice, such resolution was duly passed as an ordinary resolution of the Company.
