Electricity Sold for November 2023

China Power International Development Limited (the “Company”) announces that based on the Company’s preliminary statistics, the combined total electricity sold by the Company and its subsidiaries (collectively, the “Group”) for the eleven months ended 30 November 2023 amounted to 92,089,647MWh, representing a decrease of 5.09% compared to the same period last year.
