PERFORMANCE GUARANTEE IN RELATION TO THE VERY SUBSTANTIAL ACQUISITION

This announcement is made by Zall Smart Commerce Group Ltd. (the “**Company**”) pursuant to Rules 14.36B and 14A.63 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited.

Reference is made to the announcements of the Company dated 13 November 2016, 26 April 2023, 25 May 2023 and 26 July 2023 (collectively, the “**Announcements**”) and the circular of the Company dated 15 February 2017 (the “**Circular**”) in relation to the acquisition of the Target Companies. Unless otherwise stated, capitalised terms used herein shall have the same meanings as defined in the Circular.

As stated in the announcements of the Company dated 26 July 2023, Vendor D shall sell a total of 66,677,559 unreleased Consideration Shares to public investor(s) on or before 31 December 2023. It is expected that the sale of such unreleased Consideration Shares shall be completed on or before 30 June 2024.
