# ANNOUNCEMENT COMPLETION OF MAJOR TRANSACTION

References are made to the announcements dated April 26, 2023 and June 20, 2023 (the "Announcements") and the circular dated May 31, 2023 (the "Circular") of Guangzhou Rural Commercial Bank Co., Ltd.\* (the "Bank") in relation to the transfer of the relevant assets and the Transaction Mandate of the Bank. Unless otherwise stated, capitalised terms used in this announcement shall have the same meanings as those defined in the Announcements and the Circular.

As the highest applicable percentage ratio (as defined under the Listing Rules) in respect of the Transaction exceeds 25% but is less than 75%, the Transaction constitutes a major transaction of the Bank under Chapter 14 of the Listing Rules and is subject to the reporting, announcement and Shareholders' approval requirements under Chapter 14 of the Listing Rules. The Shareholders have considered and approved the Transaction and the Transaction Mandate at the 2022 annual general meeting held on June 20, 2023.

The Board is pleased to announce that the Transaction was completed on December 31, 2023. As of December 31, 2023, the Bank has completed the disposal and transfer of the Transferred Assets to a total of 105 buyers (the "Buyers") at a total consideration of RMB9,467 million, including (i) the disposal of the Transferred Assets to Guangzhou Huaxin Group Co., Ltd. (廣州華新集團有限公司) (which is controlled by Feng Yaoliang, a director of the Bank, as disclosed below) at a consideration of RMB18 million, and (ii) the disposal of the Transferred Assets to other Buyers who are independent third parties of the Bank at a total consideration of RMB9,449 million. The asset transfer agreements entered into between the Bank and the Buyers respectively comply with the Transaction Mandate as disclosed in the Circular, which was approved by the Shareholders on June 20, 2023. Accordingly, as of the date of this announcement, the rights, interests and obligations in respect of the Transferred Assets, the rights to request, demand, obtain and accept in respect of the receivables arising

therefrom, the aggregate amount of any debt repayment and the rights and powers in relation to the enforcement and realization of the value of such assets have been transferred from the Bank to the Buyers. As of the date of this announcement, the total consideration of the Transaction has been paid by the Buyers to the Bank in cash.
