Remarks:

The abbreviation and code of the A Share Convertible Bonds are "China Galaxy Convertible Bonds" and 113057, respectively. The adjusted conversion price of the A Share Convertible Bonds is RMB9.70 per A Share (w.e.f 17 July 2023). The term of the A Share Convertible Bonds will be six years from the date of issuance, i.e. from 24 March 2022 to 23 March 2028. The conversion period of the A Share Convertible Bonds starts from 30 September 2022 and ends on 23 March 2028. The Company's A Share Convertible Bonds totalling RMB7.8 billion were listed and traded on the Shanghai Stock Exchange on 10 May 2022. The Company has determined to exercise the right of early redemption of the A Share Convertible Bonds to redeem all the outstanding A Share Convertible Bonds on 24 November 2023. The redemption of A Share Convertible Bonds has been completed and the A Share Convertible Bonds have been delisted according to the announcements of the Company dated 6 December 2023 and 19 December 2023.
