**UNAUDITED OPERATING STATISTICS FOR DECEMBER 2023**

The board of directors (the “**Board**”) of CIFI Holdings (Group) Co. Ltd. (the “**Company**”) hereby announces certain unaudited operating statistics of the Company and its subsidiaries (the “**Group**”) for December 2023 as follows:

- In December 2023, the Group recorded (i) contracted sales (including contracted sales by joint ventures and associated companies) amounted to approximately RMB5.34 billion with contracted GFA of approximately 555,100 sq.m., (ii) contracted average selling price\* of approximately RMB13,200/sq.m., and (iii) contracted sales attributable to the equity owners of the Company of approximately RMB2.64 billion.
- From January to December 2023, the Group recorded (i) aggregated contracted sales (including contracted sales by joint ventures and associated companies) amounted to approximately RMB70.00 billion with contracted GFA of approximately 5,143,800 sq.m., (ii) contracted average selling price\* of approximately RMB14,900/sq.m., and (iii) contracted sales attributable to the equity owners of the Company of approximately RMB35.81 billion.

The above-mentioned data is unaudited and is based on preliminary internal information of the Group, which may differ from figures to be disclosed in the audited or unaudited consolidated financial statements to be published by the Company on an annual or half-yearly basis due to various uncertainties during the process of collating such sales information. As such, the above data is provided for investors’ reference only.
