INTRODUCTION

Reference is made to (i) the announcement of the Company dated 18 December 2023 in relation to the entering into of the Finance Leases A with Lessee A to obtain the ownership of Assets A at an aggregate consideration of RMB160,000,000 (equivalent to approximately HK\$175,520,000), which would be leased back to Lessee A for its use and possession for a term of 8 years; and (ii) the announcement of the Company dated 19 December 2023 in relation to the entering into of (a) the Finance Lease B with Lessee B to obtain the ownership of Assets B at a consideration of RMB40,000,000 (equivalent to approximately HK\$43,760,000), which would be leased back to Lessee B for its use and possession for a term of 8 years; and (b) the Finance Lease C with Lessee C to obtain the ownership of Assets C at a consideration of RMB70,000,000 (equivalent to approximately HK\$76,580,000), which would be leased back to Lessee C for its use and possession for a term of 6 years.

Lessee C will pay an interest-free deposit of RMB1,400,000 (equivalent to approximately HK\$1,532,000) to Greengold Leasing on the same day the consideration for Assets C transfer has been paid by Greengold Leasing to secure its payment obligations under the Finance Lease C.

Guarantee

Guarantor C had executed a guarantee on the date of the Finance Lease C guaranteeing Greengold Leasing the due and punctual settlement of any and all amount payable by Lessee C under the Finance Lease C and Existing Finance Lease C.

Pledges

Pursuant to the asset pledge agreement entered into between Greengold Leasing and Lessee C on the date of the Finance Lease C, although the ownership of Assets C shall be transferred to Greengold Leasing as lessor as part of the Finance Lease C, Assets C are treated as security of payment obligations of Lessee C under the Finance Lease C and Lessee C may continue to utilize Assets C during the lease term.

Lessee C had executed a receivables pledge agreement in favour of Greengold Leasing, pledging its rights in receivables under certain power supply agreements and their supplemental agreements (with pledged receivables in the total amount of RMB180,000,000 (equivalent to approximately HK\$196,920,000)) as security of its payment obligations under the Finance Lease C and Existing Finance Lease C.

Additionally, Lessee C had executed a pledge agreement in favour of Greengold Leasing, pledging 100% interests of its bank account (representing the pledge receivables of all the outstanding amounts due) for a term of 7 years, as security of its payment obligations under the Finance Lease C and Existing Finance Lease C.

Information on Assets C

Assets C comprise certain designated cogeneration equipment and facilities of Lessee C situated in Linyi City, Shandong Province.

Lessee C will bear any maintenance, taxation and other costs and levies associated with Assets C.

REASONS FOR AND BENEFITS OF ENTERING INTO THE FINANCE LEASES A, FINANCE LEASE B AND FINANCE LEASE C

The entering into of the Finance Leases A, Finance Lease B and Finance Lease C is part of Greengold Leasing's ordinary and usual course of business and is expected to provide a stable revenue and cashflow to the Group.

The Directors consider that the Finance Leases A, Finance Lease B and Finance Lease C and the transactions contemplated thereunder are on normal commercial terms which are made on an arm's length basis and are fair and reasonable and in the best interests of the Group and the Shareholders as a whole.

FINANCIAL EFFECTS OF THE FINANCE LEASES ARRANGEMENT

The Finance Leases A is expected to attribute approximately RMB53,026,000 (equivalent to approximately HK\$58,170,000) to the Group's turnover, from the aggregate interest income over the whole period of such Finance Leases. On the other hand, the Group is expected to bear the aggregate loan interest payments of approximately RMB14,030,000 (equivalent to approximately HK\$15,391,000) to the Group's cost of sales in respect of secured external loans.

As at the date when the consideration for the Assets A transfer was paid, the Group had also recorded on its balance sheet the Finance Lease receivables of RMB160,000,000 (equivalent to approximately HK\$175,520,000) in respect of such Finance Leases and borrowings by the Group of RMB141,600,000 (equivalent to approximately HK\$155,335,000) and decreased cash and cash equivalents of RMB18,400,000 (equivalent to approximately HK\$20,185,000) of the Group.

The Finance Lease B is expected to attribute approximately RMB13,078,000 (equivalent to approximately HK\$14,307,000) to the Group's turnover, from the aggregate interest income and other fees and expenses over the whole period of such Finance Lease. On the other hand, the Group is expected to bear the aggregate loan interest payments of approximately RMB3,573,000 (equivalent to approximately HK\$3,909,000) to the Group's cost of sales in respect of secured external loans.

As at the date when the consideration for the Assets B transfer was paid, the Group had also recorded on its balance sheet the Finance Lease receivables of RMB40,000,000 (equivalent to approximately HK\$43,760,000) in respect of such Finance Lease, borrowings by the Group of RMB32,000,000 (equivalent to approximately HK\$35,008,000) and decreased cash and cash equivalents of RMB8,000,000 (equivalent to approximately HK\$8,752,000) of the Group.

The Finance Lease C is expected to attribute approximately RMB15,048,000 (equivalent to approximately HK\$16,463,000) to the Group's turnover, from the aggregate interest income and other fees and expenses over the whole period of such Finance Lease. On the other hand, the Group is expected to bear the aggregate loan interest payments of approximately RMB6,517,000 (equivalent to approximately HK\$7,130,000) to the Group's cost of sales in respect of secured external loans.

As at the date when the consideration for the Assets C transfer was paid, the Group had also recorded on its balance sheet the Finance Lease receivables of RMB70,000,000 (equivalent to approximately HK\$76,580,000) in respect of such Finance Lease, borrowings by the Group of RMB56,000,000 (equivalent to approximately HK\$61,264,000) and decreased cash and cash equivalents of RMB14,000,000 (equivalent to approximately HK\$15,316,000) of the Group.

LISTING RULES IMPLICATION

For the Finance Leases A, as one of the applicable percentage ratios for the transactions contemplated under the Finance Leases A exceeds 25% but all of them are less than 100%, the entering into of such transactions constitutes a major transaction for the Company under the Listing Rules and is subject to the announcement, circular and shareholders' approval requirements under the Listing Rules.

For the Finance Lease B, reference is made to the discloseable transaction announcement of the Company dated 25 May 2023 in relation to the entering into of the Existing Finance Lease B1 between Greengold Leasing and Lessee B and the discloseable transaction announcement of the Company dated 15 August 2023 in relation to the entering into of the Existing Finance Lease B2 between Greengold Leasing and the then lessee pursuant to which Lessee B is one of the guarantors. As one of the applicable percentage ratios for the transactions contemplated under the Finance Lease B, when calculated on an aggregate basis with the transactions under the Existing Finance Leases B, exceeds 25% but all of them are less than 100%, the entering into of the Finance Lease B constitutes a major transaction for the Company under the Listing Rules and is subject to the announcement, circular and shareholders' approval requirements under the Listing Rules.

For the Finance Lease C, reference is made to the discloseable transaction announcement of the Company dated 13 December 2023 in relation to the entering into of the Existing Finance Lease C between Greengold Leasing and Lessee C. As one of the applicable percentage ratios for the transactions contemplated under the Finance Lease C, whether on a standalone basis or an aggregate basis with the transactions under the Existing Finance Lease C, exceeds 25% but all of them are less than 100%, the entering into of the Finance Lease C constitutes a major transaction for the Company under the Listing Rules and is subject to the announcement, circular and shareholders' approval requirements under the Listing Rules.

No Shareholder is materially interested in the Finance Leases A, Finance Lease B and Finance Lease C and no Shareholder is required to abstain from voting at a general meeting of the Company approving the transactions contemplated under the Finance Leases A, Finance Lease B and Finance Lease C, and the Company has, pursuant to Rule 14.44 of the Listing Rules, obtained written approvals of the transactions contemplated under the Finance Leases A, Finance Lease B and Finance Lease C respectively from Prize Rich Inc., a Shareholder holding 1,222,713,527 issued ordinary shares of the Company (representing 71.41% of its entire issued share capital). As such, the Company is exempted from convening a general meeting to approve the transactions contemplated under the Finance Leases A, Finance Lease B and Finance Lease C.

PRINCIPAL BUSINESSES OF THE PARTIES

The Group

The Group is principally engaged in wellness elderly care, finance leasing, property investments in both properties held for sale and investment properties, big data, civil explosives, hotel investment, management and operation businesses. Through its joint ventures and associated companies, the Group also participates and invests in fast growing sectors, including electric utilities in the PRC.

Greengold Leasing

Greengold Leasing is a subsidiary of the Company, which is principally engaged in the provision of finance, including through finance leasing, with a focus on environmental protection projects in the PRC.

The Lessees

Lessee A is a limited liability company established in the PRC and is principally engaged in sewage treatment in the PRC.

Lessee B is a limited liability company established in the PRC and is principally engaged in sewage and garbage treatment in the PRC.

Lessee C is a limited liability company established in the PRC and is principally engaged in power and heat generation and supply in the PRC.

The Guarantors

Guarantor A1 and Guarantor A2 are natural persons. Guarantor A1 is a director of several companies which are engaged in business management. Guarantor A2 is an entrepreneur who is engaged in business management and sewage treatment industry.

Guarantor A3 is a limited liability company established in the PRC and is principally engaged in promotion and investment of environmental protection technology research and development in the PRC.

Guarantor A4 is a limited liability company established in the PRC and is principally engaged in investments and asset management in the PRC.

Guarantor B1 is a limited liability company established in the PRC and is principally engaged in sewage treatment in the PRC.

Guarantor B2 is a limited liability company established in the PRC and is principally engaged in sewage treatment in the PRC.

Guarantor B3 is a natural person and is a director of several companies which are engaged in the sewage treatment industry.

Guarantor C is a limited liability company established in the PRC and is principally engaged in solid waste treatment, biomass power generation and heat supply in the PRC.

RECOMMENDATIONS

The Directors consider that the terms of the Finance Lease A, Finance Lease B and Finance Lease C and the transactions contemplated thereunder are on normal commercial terms which are made on an arm's length basis and are fair and reasonable, and in the best interests of the Group and the Shareholders as a whole.

Accordingly, if a general meeting were to be convened, the Board would recommend the Shareholders to vote in favour of the ordinary resolutions to approve the Finance Leases A, Finance Lease B and Finance Lease C and the transactions contemplated thereunder at such general meeting.

2. INDEBTEDNESS STATEMENT

As at the close of business on 30 November 2023, the Group had outstanding interest bearing bank loans of approximately HK\$4,766,645,000 (comprising secured and guaranteed bank loans of approximately HK\$4,217,440,000 which were secured by the pledge of investment properties of HK\$353,190,000, plant, property and equipment of HK\$372,764,000, bank deposit of HK\$6,950,000, finance lease receivables and future interest receivable of HK\$3,239,639,000, paid-up capital of a non-wholly owned subsidiary of HK\$222,801,000 and a future rental receivable from the properties; and unsecured and unguaranteed bank loans of approximately HK\$549,205,000. Among such loans, a small number of them are having a maturity profile in the near term (maturing in 2023) and the rest are in the midterm (maturing in 2024, 2025 and 2026) to long term (maturing in 2027, 2028, 2029, 2035, 2037, 2038, 2043, 2046 and 2047).

FINANCIAL INFORMATION OF THE GROUP

The Group had unsecured and unguaranteed interest bearing loans from its immediate holding company and non-controlling interest of approximately HK\$136,000,000 and HK\$28,419,000 respectively, all of which will mature in 2024 and 2025. The Group also had unsecured and unguaranteed interest bearing loans from other independent third parties of approximately HK\$76,828,000. All loans will mature in 2024.

The Group had outstanding secured and guaranteed asset backed securities of approximately HK\$89,376,000 by the pledge of finance lease receivables and future interest receivable of HK\$125,226,000 and unsecured and guaranteed other bonds of approximately HK\$329,263,000.

In addition, the Group had unsecured and unguaranteed lease liabilities and outstanding convertible notes of approximately HK\$1,045,419,000 and aggregate principal amount of HK\$166,232,000 issued by the Company will mature on 13 October 2024 respectively.

Save as aforesaid or otherwise disclosed herein, as at the close of business on 30 November 2023, the Group did not have any debt securities issued and outstanding or agreed to be issued, bank overdrafts, loans or other similar indebtedness, liabilities under acceptances or acceptance credits, debentures, mortgages, charges, hire purchase commitments, guarantees or other contingent liabilities.

3. MATERIAL ADVERSE CHANGE

At the Latest Practicable Date, the Directors confirm that there had been no material adverse change in the financial or trading position of the Group since 31 December 2022, being the date to which the latest published audited consolidated financial statements of the Company were made up.

4. WORKING CAPITAL

The Directors, after due and careful enquiry, are of the opinion that, taking into account the existing cash and bank balances, other internal resources and available existing unutilised credit facilities, the Group has sufficient working capital for its present requirements and to satisfy its requirements for at least the next 12 months from the date of publication of this circular in the absence of unforeseen circumstances.

The Company has obtained the relevant confirmation as required under Rule 14.66 (12) of the Listing Rules.

5. FINANCIAL AND TRADING PROSPECT OF THE GROUP

The global economy remains unstable, and economic growth remains slow, while rate hikes dampened consumer spending and corporate investment, and threatened the stability of the financial system. With more economic uncertainties as a result of the war in Ukraine, the insufficient total demand in China, the new headwinds of economic restructuring and upgrading, the unsatisfactory operation of enterprises in various industries, the sluggishness of real estate development and construction, the Group is still committed to its strategic mission by proactively adjusting its deployment, cohesively pursuing its core business. The Group will constantly enhance its business activities, and steadily develop its business in elderly care and wellness, financial leasing, industrial parks/property investment, big data and civil explosives.

For our elderly care and wellness business, Guangdong Taoyuan Comprehensive Health Operation Company Limited ("Taoyuan Comprehensive Health") will continue to consolidate its elderly care business and strengthen its principal business. The Group will strengthen the standard operation and branding of its elderly care business, proactively expand its asset-light trustee operation, increase the number of operating beds, and seize the opportunity to become the first echelon in the Guangdong-Hong Kong-Macao Greater Bay Area, and in this way, it will introduce long-term strategic investors whose business will mutually empower the Group. In terms of medical and care services integration, the Group has been promoting care service with medical service and assisting medical service with care service by establishing a rehabilitation hospital focusing on geriatrics and rehabilitation and building a regional medical and care service consortium with the People's Hospital of the district. Our community care and household care business operations are based on the community-rooted Taoyuan Intelligent Recreation Port and are actively striving for market share. In addition, the Company is committed to serving the community while enabling our elderly care and wellness business to continue to grow and become an important contributor to the Company's profitability by further improving management, reducing costs, increasing efficiency, enhancing the quality and strengthening service quality.

For our big data business, the Group will continue its efforts to expand its market scale and accelerate the implementation of investments and acquisitions. The Group will continue to boost the scale of the identification application market by further solidifying its cooperation with ICT, FTU and operators, and actively striving for the construction of identification nodes and the declaration of special projects. The Group will also continue to make our service products the rigid demand of manufacturing enterprises and the government, create a quality manufacturing service brand and render "commonality" services to manufacturing enterprises as a collaborative partner, and promote the implementation of a new round of investment and acquisition projects. The Group will complete the launch of the new product DEMO and the Code for Success APP in light of the market demand and product feedback, and continue to diversify its product offering to promote the quality development of the Company. The Group will continue to be positioned as a first-class provider of industrial Internet platform services in the Guangdong-Hong Kong-Macao Greater Bay Area, actively engage in merger and acquisition initiatives and integration, and develop and become stronger in the tide of transformation and upgrading of Industry 4.0 in Nanhai, Foshan, the Guangdong-Hong Kong-Macao Greater Bay Area and in China.

FINANCIAL INFORMATION OF THE GROUP

For our financial leasing business, with the strategic goal of developing it into a leading domestic professional financial leasing company featuring environmental protection, the Group will continue to intensively tap into segments of the municipal environmental protection industry, vigorously tap into the upstream and downstream of its partners, and intensify its effort in the direct leasing business of environmental protection equipment and high-end equipment. To improve fund management, the Group will conduct effective management and replace existing high-cost financing to alleviate the pressure of concentrated repayment at maturity and the cost of funds; complete the rating of entities and strive to attain an AA rating after the completion of industrial and commercial changes. The Group will further strengthen its risk control management to mitigate the risk of doubtful debts and strive to attain an A rating for the annual classified supervisory rating.

For our civil explosives business, the Group will further pursue key reforms, actively carry out the technological transformation of clean energy to achieve energy conservation, emission reduction and cost reduction, and carry out reforms in operation and human resources management to continuously enhance the vitality of the Group's development. The Group has made every effort to complete creating conditions for the release of mixed assembly capacity and to establish cooperation in the operation of mixed assembly capacity, so as to substantially improve its future performance and contribute steady revenue streams to the Group in the future.

For our property and industrial park business operated under our non-wholly owned subsidiary Guangdong Sino Rock Tyco Construction Co., Ltd.* (廣東中岩泰科建設有限公司) ("Sino Rock Tyco"), the Group will complement the first and second phases of the project with the rental housing (Dan Qing Garden) and accelerate the development of the third and fourth phases of the project as part of its ongoing operations. As disclosed in the Company's announcement of 6 December 2023, to maintain adaptability and mitigate against market risks as part of its periodic review of business segments from time to time to optimize strategic positioning, the Company has entered into an agreement to dispose of its equity interest and realise its investment in Sino Rock Tyco, which is expected to be completed in the first quarter of 2024. The Group will cease to engage in the industrial parks and property development business as a result of such disposal. Further information related to such disposal has been disclosed in the circular of the Company dated 29 December 2023.

In addition, the Group will aggressively explore opportunities to carry out investment and merger and acquisition of biopharmaceutical and high-tech enterprises or projects to seek leapfrog development of the business of the Company, thereby delivering good returns to the shareholders of the Company.
