## **ANNOUNCEMENT POWER GENERATION FOR DECEMBER 2023**

This announcement is made pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited and Inside Information Provisions under Part XIVA of the Securities and Futures Ordinance (Cap. 571, Laws of Hong Kong).

The board of directors (the “**Board**”) of China Longyuan Power Group Corporation Limited\* (the “**Company**”) announces that, according to the Company’s preliminary statistics, the power generation of the Company and its subsidiaries (the “**Group**”) for December 2023 on a consolidated basis amounted to 7,740,981 MWh, representing a year-on-year increase of 10.13% as compared with the corresponding period of 2022. In particular, the wind power generation registered an increase of 5.47%, the coal-fired power generation registered a decrease of 0.68%, and other renewable energy power generation registered an increase of 279.00%. As of 31 December 2023, the total power generation of the Group for 2023 amounted to 76,225,816 MWh, representing a year-on-year increase of 7.92% as compared with the corresponding period of 2022. In particular, the wind power generation registered an increase of 5.22%, the coal-fired power generation registered a decrease of 2.39%, and other renewable energy power generation registered an increase of 159.83%.
