Lygend Resources & Technology Co., Ltd. (the "Company") has received the filing notice from the China Securities Regulatory Commission and the approval from The Stock Exchange of Hong Kong Limited (the "Stock Exchange") of the conversion of 265,453,750 unlisted shares of the Company into H shares of the Company (the "H Shares") and their listing on the Stock Exchange, as disclosed in the announcements of the Company dated 20 July 2023, 23 August 2023, 11 January 2024 and 15 January 2024 respectively. The relevant conversion was completed on 15 January 2024, as disclosed in the announcement of the Company dated 15 January 2024. The listing of the converted H Shares on the Stock Exchange commences on 16 January 2024.

Following the conversion, the H Shares increased by 265,453,750 shares, while the Domestic Shares and the Unlisted Foreign Shares decreased by 1,900,000 shares and 263,553,750 shares respectively. The total number of issued shares of the Company after the conversion remains unchanged, comprising 503,616,350 H Shares and 1,052,315,000 Domestic Shares.
