Prudential plc (the “**Company**”) announces today it has purchased the following number of its ordinary shares of 5 pence each through Barclays Capital Securities Ltd (the “**Bank**”) on the London Stock Exchange in accordance with the authority granted by shareholders at the Company’s 2023 Annual General Meeting (the “**Purchase**”). The Purchase was effected in accordance with the non-discretionary agreement entered into with the Bank, as announced on 5 January 2024.
