Arrangement of Electronic Dissemination of Corporate Communications

Pursuant to Rule 2.07 of the Rules Governing The Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) under the expansion of paperless listing regime and electronic dissemination of corporate communications that came into effect on 31 December 2023 (the “**Regime**”), YNBY International Limited (the “**Company**”) is writing to inform you that the Company will adopt the electronic dissemination of corporate communications (the “**Corporate Communications**”) upon passing of the resolutions by the shareholders of the Company at the next general meeting (“**Next GM**”) to approve and adopt the proposed amendments to the bye-laws of the Company in relation to the implementation of the Regime (“**Implementation of the Regime**”). Please note that both the English and Chinese versions of all future Corporate Communications will be available electronically on the website of the Company at www.0030.com.hk and the HKEXnews website at www.hkexnews.hk in place of printed copies.

As a non-registered shareholder, if you wish to receive corporate communications from the Company pursuant to the Listing Rules, you should liaise with your bank(s), broker(s), custodian(s), nominee(s) or HKSCC Nominees Limited through which your Shares are held (collectively, the “Intermediaries”) and provide your email address to your Intermediaries. Your instruction shall become effective immediately upon the passing of the resolutions at the Next GM in relation to Implementation of the Regime, and your instruction will apply to all future Corporate Communications of the Company to be sent to you until you notify your Intermediaries to the contrary or unless you have at any time ceased to have shareholdings in the Company.

If the Company does not receive your functional email address from the Intermediaries, until such time that the functional email address is provided to the Intermediaries, you will (i) be unable to receive any notifications regarding the publication of Corporate Communications; (ii) need to proactively check the Company’s website and the HKEXnews website to keep up with the publication of Corporate Communications; and (iii) the Company will send the Actionable Corporate Communications^(Note) in printed form in the future.
