UNAUDITED OPERATING FIGURES FOR DECEMBER 2023

The board of directors (the “**Board**”) of Sanxun Holdings Group Limited (the “**Company**”) wishes to provide the shareholders of the Company and potential investors with a sales update containing certain operating data of the Group for the twelve months ended 31 December 2023. For the twelve months ended 31 December 2023, the aggregate contracted sales of the Company, its subsidiaries and associated companies (the “**Group**”) was approximately RMB783 million, the aggregate contracted gross floor area was 108,278 sq.m. and the average selling price was approximately RMB7,233.6 per sq.m..
