OVERSEAS REGULATORY ANNOUNCEMENT Power Generation and On-grid Tariff for the Year 2023 and Commencement of Operation of Power Generating Units

This announcement is made pursuant to Rule 13.10B of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited.

As at 31 December 2023, the total amount of power generated by Huadian Power International Corporation Limited* (the "**Company**") and its subsidiaries (the "**Group**") calculated on the basis of the consolidated financial statements of the Group according to the China Accounting Standards for Business Enterprises for the year 2023 was 223.80 million MWh, representing an increase of approximately 1.30% as compared with that of the same period of the previous year; and the total amount of on-grid electricity sold was 209.55 million MWh, representing an increase of approximately 1.21% as compared with that of the same period of the previous year. The increase in power generation and on-grid electricity sold for the year 2023 was mainly attributable to the impact of the electricity demand growth in the whole society, and the operation of the newly added generating units of the Group. The average tariff of on-grid electricity sold by the Group for the year 2023 was approximately RMB 516.78 per MWh.
