**ANNOUNCEMENT ON UNAUDITED OPERATING DATA
FOR THE FOURTH QUARTER OF
THE THREE MONTHS ENDED 31 DECEMBER 2023 AND
THE YEAR ENDED 31 DECEMBER 2023**

This announcement is voluntarily made by Dynagreen Environmental Protection Group Co., Ltd.* (the “**Company**”, together with its subsidiaries, the “**Group**”).

The board of directors (the “**Board**”) of the Company is pleased to announce that the unaudited waste input volume, electricity generation volume, on-grid electricity volume and steam supply volume of the Group amounted to 3,454,500 tons, 1,265,006,100 kWh, 1,045,709,900 kWh and 127,800 tons respectively in the fourth quarter of the three months ended 31 December 2023. For the year ended 31 December 2023, the unaudited accumulated waste input volume of the Group amounted to 13,446,800 tons, representing a year-on-year increase of 17.98%; the accumulated electricity generation volume was 4,725,805,800 kWh, representing a year-on-year increase of 11.50%; the accumulated on-grid electricity volume was 3,894,231,000 kWh, representing a year-on-year increase of 11.87%; and the accumulated steam supply volume was 428,600 tons, representing a year-on-year increase of 42.00%.
