Dear non-registered shareholder(s),

Arrangement of Electronic Dissemination of Corporate Communications

Pursuant to Rules 2.07A and 2.07B of the Rules Governing The Listing of Securities on The Stock Exchange of Hong Kong Limited (the "Listing Rules") under the expansion of paperless listing regime and electronic dissemination of corporate communications that came into effect on 31 December 2023, the Articles of Association of Kong Sun Holdings Limited (the "Company") and the Companies Ordinance (Chapter 622 of the Laws of Hong Kong), the Company is writing to inform you that the Company has adopted electronic dissemination of corporate communications (the "Corporate Communications"), which mean any documents issued or to be issued by the Company for the information or action of holders of any of its securities, including but not limited to (a) the directors' report, its annual accounts together with a copy of the auditors' report and, where applicable, its summary financial report; (b) the interim report and, where applicable, its summary interim report; (c) a notice of meeting; (d) a listing document; (e) a circular and (f) a proxy form.

Please note that with effect from the date hereof, both the English and Chinese versions of all future Corporate Communications will be available electronically on the website of the Company at <u>www.kongsun.com</u> and the HKEXnews website at <u>www.hkexnews.hk</u> in place of printed copies (unless requested by the shareholders of the Company (the "**Shareholders**")). The Company will send all Actionable Corporate Communications* to the Shareholders individually in electronic form by email or, if the Company does not possess the email address of a Shareholder or if the email address provided is not functional, the Company will send the Actionable Corporate Communications* in printed form together with a request form for soliciting the Shareholder's functional email address to facilitate electronic dissemination of Actionable Corporate Communications* in the future.

As a non-registered shareholder, if you wish to receive future Corporate Communications pursuant to the Listing Rules, you should liaise with your bank(s), broker(s), custodian(s), nominee(s) or HKSCC Nominees Limited through which your Shares are held (collectively, the "Intermediaries") and provide your email address to your Intermediaries.

If the Company does not receive your functional email address from the Intermediaries, until such time that the functional email address is provided to the Intermediaries, you will (i) be unable to receive any notifications regarding the publication of Corporate Communications on the website of the Company; and (ii) need to proactively check the Company's website and the HKEXnews website to keep up with the publication of Corporate Communications.
