The High Court of Hong Kong has directed the hearing for Petition I to be heard before a Master on 6 March 2024.

The Company is now actively seeking legal advice in respect of Petition I, and will adopt all effective rescuing and releasing measures, including but not limited to proposing a debt restructuring plan to the creditors of the Company and seeking possible investment to raise funds for the Company.

As at the date of this announcement, the Company has continuously made progress in the fulfilment of the Resumption Guidance by implementing its resumption plan and is currently working with its professional advisors to fulfill the Resumption Guidance as soon as practicable. On 17 January 2024, the Group has published its unaudited interim financial results of the Group for the six months ended 30 June 2022 by means of the Company's despatching of interim results announcement and the interim report.
