DISCLOSEABLE TRANSACTION PROVISION OF FINANCIAL ASSISTANCE

PROVISION OF FINANCIAL ASSISTANCE

The Board is pleased to announce that on 2 February 2024, the New Loan Agreement was entered into between CDVC as the lender and Customer X as the Borrower, pursuant to which CDVC has agreed to grant the New Loan to the Borrower for a principal amount of RMB2,600,000 for one year term.

Prior to the entering into of the New Loan Agreement, CDVC, as lender, has entered into two Previous Loan Agreements for the grant of two secured loans in the aggregate amount of RMB6,400,000 to the Borrower for one year term on 22 September 2023 and 15 August 2023 respectively and the outstanding aggregate principal amount of the Previous Loans as at the date of this announcement is RMB6,400,000. Details of the Previous Loan Agreements have been previously disclosed in the announcement of the Company dated 22 September 2023.

Upon the drawdown of the New Loan, CDVC has granted three secured loans in an aggregate amount of RMB9,000,000 to the Borrower.

LISTING RULES IMPLICATIONS

As an applicable percentage ratio under Rule 14.07 of the Listing Rules in respect of both New Loan and Previous Loans granted to the Borrower in aggregate exceeds 5% but is less than 25%, the grant of both New Loan and Previous Loans in aggregate constitutes a discloseable transaction for the Company and is subject to notification and announcement requirements under Chapter 14 of the Listing Rules.

PROVISION OF THE NEW LOAN

The Board is pleased to announce that on 2 February 2024, the New Loan Agreement was entered into between CDVC as the lender and Customer X as the Borrower, pursuant to which CDVC has agreed to grant the New Loan to the Borrower for a principal amount of RMB2,600,000 for one year term.

Summarised below are the principal terms of the New Loan Agreement.

THE NEW LOAN AGREEMENT

Date of Agreement	:	2 February 2024
Lender	:	CDVC
Borrower	:	Customer X

Interest rate	:	14.28% per annum
Term	:	12 months commencing from the drawdown date
Security	:	(i) A second legal charge mortgage in respect of an apartment located at Tianfu New Area District, Chengdu, with valuation conducted by an independent property valuer in Chengdu with the amount of approximately RMB15,438,000 as at 29 January 2024 (ii) Personal guarantees executed by the Guarantors in favour of CDVC, pursuant to which the Guarantors shall guarantee the repayment obligations of the Borrower under the New Loan Agreement
Repayment	:	the Borrower will repay the interest on a monthly basis with a principal amount to be repaid at maturity.

Details of the Previous Loan Agreements have been previously disclosed in the announcement of the Company dated 22 September 2023.

INFORMATION ON THE CREDIT RISK RELATING TO THE NEW LOAN

The making of the New Loan is collateralised against an apartment. The collateral provided by the Borrower for the New Loan is sufficient based on the value of the mortgaged property for the New Loan as determined by independent valuer.

The advances in respect of the New Loan are also made on the basis of the Company's credit assessments with reference to the facts that (i) the collateral provided by the Borrower are at the prime site in Chengdu; (ii) the Borrower is a repeated customer and its net worth is strong and solid to prove its repayment ability; (iii) the repayment records of the Previous Loans are satisfactory; and (iv) the relatively short term nature of New Loan. After taking into account the factors as disclosed above in assessing the risks of the relevant advances, the Company considers that the risks involved in the advances to the Borrower are manageable.

FUNDING OF THE NEW LOAN

The Group will finance the New Loan with the Company's general working capital.

INFORMATION ON THE BORROWER

Customer X is a limited liability company established in the PRC whose principal business is property investment and is a repeated customer of CDVC with an outstanding principal of the Previous Loans, prior to the grant of the New Loan, of RMB6,400,000 and there is no record of default as at the date of this announcement. To the best of the knowledge, information and belief of the Directors having made all reasonable enquiry, the Borrower and all its beneficial owners are Independent Third Parties and not connected with the Group.

INFORMATION ON THE GROUP AND THE LENDER

The Company is an investment holding company. The Group is principally engaged in provision of financial services in HK and the PRC. CDVC, as the lender of the New Loan and the Previous Loan, is a non wholly-owned subsidiary controlled by the Company.

REASONS FOR ENTERING INTO THE NEW LOAN AGREEMENT

Taking into account the principal business activities of the Group, the grant of the New Loan to the Borrower is in the ordinary and usual course of business of the Group.

The terms of the New Loan Agreement, including the interest rate applicable, were negotiated on an arm's length basis between CDVC and the Borrower, having taken into account the prevailing market terms and practice of transactions of similar nature. The Directors consider that the grant of the New Loan is a financial assistance provided by the Group within the meaning of the Listing Rules. The Directors are of the view that the terms of the New Loan Agreement were entered into on normal commercial terms based on the Group's credit policy. Taking into account the satisfactory financial background of the Borrower and that a stable revenue and cashflow stream from the interest income is expected, the Directors consider that the terms of the New Loan Agreement are fair and reasonable and the entering into of the New Loan Agreement is in the interests of the Company and its Shareholders as a whole.
