1. Property Sales Update

For January 2024, the contracted property sales of the China Overseas Series of Companies amounted to approximately RMB10.504 billion, with a year-on-year decrease of 20.4%; and the corresponding gross floor area ("GFA") sold was approximately 560,400 square meters, with a year-on-year decrease of 21.2%. Details of the contracted property sales and the corresponding GFA are set out in Table 1 below.

In addition, as at 31 January 2024, the China Overseas Series of Companies had recorded subscribed property sales of approximately RMB15.977 billion, which are expected to be turned into contracted property sales in the following months.
