Arrangements for Dissemination of Corporate Communications²

Pursuant to the amended Rule 2.07A of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the "Listing Rules") effective from 31 December 2023 regarding the use of electronic means for dissemination of Corporate Communications under the paperless listing regime, Café de Coral Holdings Limited (the "Company") will disseminate future Corporate Communications to its registered shareholders (the "Shareholders") as outlined below to comply with the Listing Rules and the relevant provisions of the Company's Bye-laws.

CORPORATE COMMUNICATIONS

Corporate Communications in printed form will only be sent to Shareholders upon request.

Shareholders may register for "News Alerts" service in the Market Data section of the HKEX's website to receive instant notification of the Company's publication of Corporate Communications on website.

ACTIONABLE CORPORATE COMMUNICATIONS³

The Company will send Actionable Corporate Communications to Shareholders individually in electronic form by email. If a Shareholder has not provided an email address or if the email address provided is not functional, the Company will send Actionable Corporate Communications in printed form together with a request form for soliciting the Shareholder's functional email address to enable electronic dissemination in future.

The Company will be considered to have complied with the Listing Rules if it sends Actionable Corporate Communications to the email address provided by a Shareholder without receiving any "non-delivery message".

Shareholders are entitled at any time by reasonable prior notice in writing to the Company c/o the Share Registrar to request for future Corporate Communications in printed form free of charge. A Shareholder may make such request by completing the relevant section of the enclosed Reply Form and returning the completed form to the Share Registrar by email or by post at the addresses set out above. Any such request shall be valid for one year from the date of receipt of the request unless being revoked or superseded (whichever is earlier), and further request in writing shall be required if the Shareholder wishes to continue receiving Corporate Communications in printed form.

Owing to the above arrangements, Shareholders' previous requests (if any) to receive Corporate Communications in printed form shall no longer be valid.
