UPDATE ON WINDING-UP PETITION

This announcement is made by Silk Road Logistics Holdings Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Inside Information Provisions (as defined in the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong) and Rule 13.09 of the Rules (the “**Listing Rules**”) Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”).

References are made to the announcements (collectively, the “**Announcements**”) of the Company dated 21 August 2023, 1 November 2023, 13 December 2023 and 8 February 2024 in relation to, among others, the hearing for the Petition which was further adjourned to 19 February 2024 and the hearing for sanctioning the Scheme which was adjourned to 12 April 2024 having considered the review hearing of the Delisting Decision to be held on 22 March 2024. Capitalised terms used in this announcement have the same meaning as those defined in the Announcements, unless the context requires otherwise.

The Company wishes to update the Shareholders and potential investors of the Company that at the adjourned hearing for the Petition on 19 February 2024, the High Court has ordered the hearing be further adjourned to 15 April 2024.

At the request of the Company, trading in the shares of the Company on the Stock Exchange has been suspended with effect from 9:00 a.m. on Tuesday, 24 May 2022.
