### **VOLUNTARY ANNOUNCEMENT INCLUSION AS A CONSTITUENT OF MULTIPLE HANG SENG INDEXES**

This is a voluntary announcement made by China Chunlai Education Group Co., Ltd. (the “**Company**”, together with its subsidiaries and consolidated affiliated entities, the “**Group**”).

The board (the “**Board**”) of directors (the “**Directors**”) of the Company is pleased to announce that the Company will be included as a constituent stock of the following indexes by the Hang Seng Indexes Company Limited with effect from 4 March 2024:

The Hang Seng Composite Index (“**HSCI**”) offers a comprehensive Hong Kong market benchmark that covers about the top 95th percentile of the total market capitalization of companies listed on the Main Board of The Stock Exchange of Hong Kong Limited. The HSCI can be used as a basis for index funds, mutual funds as well as performance benchmarks, and assists international and local investors in formulating investment strategies. Inclusion into the HSCI will allow the Company’s stock to be eligible for trading on the Hong Kong Stock Connect, a channel for stock trading between investors in Hong Kong and those in Mainland China.

As set out in the announcement of the Company dated 14 August 2023, the Company has been included as a constituent of the MSCI China Small Cap Index since after market close on 31 August 2023. The Board considers that the new inclusion of the Company as a constituent of multiple Hang Seng indexes further reflects the increased recognition from global investors of the operating performance and development potential of the Group. It is expected that the publicity of the Company will be enhanced and the liquidity on the dealing of shares of the Company will be improved, thereby providing the Group with more business development and cooperation possibilities.
