The board of directors (the "Board") of the Company wishes to inform the shareholders of the Company (the "Shareholders") and potential investors that, based on a preliminary assessment on the unaudited condensed consolidated management accounts of the Group for the six months ended 31 December 2023 and the information currently available, it is expected that the Group's net loss for the six months ended 31 December 2023 will be reduced to approximately HK\$38 million, as compared to a net loss of approximately HK\$391 million for the six months ended 31 December 2022. The Board believes that such decrease in net loss is primarily due to the reduction in the loss on fair value of the Group's investment properties as a consequence of the steady real estate market in Zhengzhou, the People's Republic of China in the second half year of 2023.

The Company is still in the process of finalising the interim results of the Group for the six months ended 31 December 2023. The information contained in this announcement is only based on the preliminary assessment by the Board according to the unaudited condensed consolidated management accounts of the Group for the six months ended 31 December 2023 and is subject to approval by the Board.
