Arrangement of Electronic Dissemination of Corporate Communications

Introduction

Pursuant to Rule 2.07 of the Rules Governing The Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) under the expansion of paperless listing regime and electronic dissemination of corporate communications that came into effect on 31 December 2023, InnoCare Pharma Limited (the “**Company**”) is writing to inform you that the Company has adopted electronic dissemination of future corporate communications (the “**Corporate Communications**”) (Note 1) to its shareholders (the “**Shareholders**”) and will only send Corporate Communications in printed form to its shareholders upon request.
