ANNOUNCEMENT PURSUANT TO RULE 13.51B(2) OF THE LISTING RULES

This announcement is made by Shangri-La Asia Limited ("**Company**") pursuant to Rule 13.51B(2) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited ("**Listing Rules**").

The Company was informed that, on 28 February 2024, Mr Forrest LI, an independent nonexecutive director of the Company, received service of process in relation to a putative securities fraud class action lawsuit ("**Lawsuit**") filed against Sea Limited (NYSE: SE) ("**Sea**") and certain of its officers, including Mr Forrest LI, in the United States District Court for the District of Arizona. The Lawsuit alleges that the defendants made misstatements or omissions of material fact in violation of the U.S. Securities Exchange Act of 1934.

Such litigation is not uncommon among companies listed in the United States. The Lawsuit is at a very preliminary stage, and while the outcome is uncertain, Mr LI has informed the Company that he believes the Lawsuit is without merit and that Sea, Mr LI, and the other defendants will defend the Lawsuit vigorously.

The Lawsuit does not involve the Company, its subsidiaries and consolidated affiliated entities ("**Group**") and is unrelated to the Group's business and operations.

Save as disclosed herein, there is no other information relating to the Lawsuit that shall be disclosed pursuant to Rule 13.51B(2) of the Listing Rules nor any matters which need to be brought to the attention of the shareholders of the Company.
