The board of directors (the “**Board**”) of Agile Group Holdings Limited (the “**Company**”) is pleased to announce that for February 2024, the aggregated pre-sale value of the Company and its subsidiaries (the “**Group**”), together with the joint ventures and associates of the Group as well as property projects carrying “Agile” brand name managed by the Group (“**Agile Projects**”) is RMB1.54 billion with corresponding gross floor area (“**GFA**”) of 107,000 sq.m.. The average selling price is RMB14,381 per sq.m..

For the two months ended 29 February 2024, the aggregated pre-sale value of the Group, together with the joint ventures and associates of the Group as well as the Agile Projects is RMB3.92 billion with corresponding GFA of 272,000 sq.m.. The average selling price is RMB14,400 per sq.m..
