## ANNOUNCEMENT POWER GENERATION FOR FEBRUARY 2024

This announcement is made pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited and Inside Information Provisions under Part XIVA of the Securities and Futures Ordinance (Cap. 571, Laws of Hong Kong).

The board of directors (the "**Board**") of China Longyuan Power Group Corporation Limited\* (the "**Company**") announces that, according to the Company's preliminary statistics, the power generation of the Company and its subsidiaries (the "**Group**") for February 2024 on a consolidated basis amounted to 6,476,274 MWh, representing a year-on-year increase of 9.56% as compared with the corresponding period of 2023. In particular, the wind power generation registered an increase of 8.81%, the coal-fired power generation registered a decrease of 19.69%, and other renewable energy power generation registered an increase of 191.96%. As of 29 February 2024, the total power generation of the Group for 2024 amounted to 13,467,165 MWh, representing a year-on-year increase of 5.55% as compared with the corresponding period of 2023. In particular, the wind power generation registered a decrease of 0.62%, the coal-fired power generation registered an increase of 7.81%, and other renewable energy power generation registered an increase of 231.30%.
