### **ISSUANCE OF FILING NOTICE BY THE CSRC FOR THE “H SHARE FULL CIRCULATION” BY THE COMPANY**

This announcement is made by CALB Group Co., Ltd. (the “**Company**”) pursuant to Rule 13.09(2) of the Rules Governing the Listing of Securities (the “**Listing Rules**”) on The Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”) and the Inside Information Provisions (as defined in the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

Reference is made to the announcement of the Company dated January 29, 2024 (the “**Announcement**”) in relation to the proposed implementation of the “H Share Full Circulation” of certain domestic shares of the Company (the “**Domestic Share(s)**”). Unless otherwise defined, capitalized terms used herein shall have the same meanings as those defined in the Announcement.

The Board is pleased to announce that the Company has received a filing notice dated March 7, 2024 (the “**Filing Notice**”) issued by the CSRC in respect of the implementation of the “H Share Full Circulation” today. According to the Filing Notice, the filing made by the Company with the CSRC in respect of the implementation of the “H Share Full Circulation” for an aggregate of 345,822,805 Domestic Shares has been completed. The Filing Notice is valid for 12 months from March 7, 2024. The Company will apply to the listing committee of the Stock Exchange for the approval of the listing and permission to deal in the relevant H Shares.

As of the date of this announcement, details of the implementation plan of the “H Share Full Circulation” and the Conversion and Listing have not been finalized. The Company will make further announcement(s) on the progress of the “H Share Full Circulation” and the Conversion and Listing in accordance with the Inside Information Provisions and/or the requirements of the Listing Rules.
