If no email address is provided, we shall send you the notification by post. If you, for any reason, have difficulty in gaining access to the relevant documents, we shall promptly send printed version of the same to you free of charge upon request.

You are entitled to change your choice at any time by reasonable notice in writing to the Unit Registrar either by post, by email or by fax.
