Announcement Trading Update Power Generation For February 2024

This announcement is made by CGN New Energy Holdings Co., Ltd. (the "Company") on a voluntary basis.

The board (the "Board") of directors (the "Directors") of the Company announces that, according to the preliminary statistics of the Company, the power generation of the Company and its subsidiaries (the "Group") on a consolidated basis amounted to 1,452.5GWh for the month of February 2024, representing an increase of 10.4% compared with the corresponding period of 2023. In particular, power generation of PRC wind projects increased by 21.4%, power generation of PRC solar projects increased by 13.7%, power generation of PRC cogen and gas-fired projects remained unchanged, power generation of PRC hydro projects increased by 7.2% and power generation of Korea projects decreased by 10.9%. For the two months ended 29 February 2024, the accumulated power generation of the Group amounted to 3,103.9GWh, representing a decrease of 2.5% compared with the corresponding period of 2023. In particular, power generation of PRC wind projects increased by 2.4%, power generation of PRC solar projects increased by 14.1%, power generation of PRC cogen and gas-fired projects increased by 13.5%, power generation of PRC hydro projects increased by 11.2% and power generation of Korea projects decreased by 13.7%.
