## **SUMMARY OF POWER GENERATION FOR DECEMBER 2023**

This voluntary announcement is made by Shandong Hi-Speed New Energy Group Limited (the "**Company**", together with its subsidiaries, the "**Group**") to keep the shareholders and potential investors of the Company informed of the latest business development of the Group.

The board (the "**Board**") of directors (the "**Directors**") of the Company announces that, according to the Company's preliminary statistics currently available, the power generation of the Group on a consolidated basis amounted to approximately 431,193 megawatt-hour ("**MWh**") for December 2023, representing an increase of approximately 20.7% compared with the corresponding period of 2022. For the year ended 31 December 2023 (the "**Year**"), the aggregate power generation of the Group amounted to approximately 5,643,935 MWh, representing an increase of approximately 5,643,935 MWh, representing an increase of approximately 14.5% compared with the corresponding period of 2022.

The operating power generation\* of the projects held and/or managed by the Group, the associates and the joint ventures of the Group for December 2023 was approximately 461,553 MWh, representing an increase of approximately 5.2% compared with the corresponding period of 2022. For the Year, the aggregate operating power generation of the projects held and/or managed by the Group, the associates and the joint ventures of the Group amounted to approximately 6,235,215 MWh, representing an increase of approximately 2.6% compared with the corresponding period of 2022.
