You have the right at any time to change your elected means of receipt and choice of language of the Corporate Communication(s) by providing reasonable notice in writing (not less than 7 days) to the Company c/o the Hong Kong Share Registrar or email at 1104-ecom@hk.tricorglobal.com. If for any reason you have difficulty in receiving or gaining access to the Website Version of the Corporate Communication(s), the Company will, upon your request in writing or by email, promptly send the printed version(s) of the Corporate Communication(s) to you free of charge.
