ENTRUSTMENT AGREEMENT FOR AUXILIARY RECLAIMED WATER NETWORKS OF NEW RESIDENTIAL AND PUBLIC HOUSING IN TIANJIN

The Board is pleased to announce that on 14 March 2024, the Board has considered and approved the Auxiliary Heat Supply Contract for Houtai Lot G Project ("**Heat Supply Agreement**"), pursuant to which, Tianjin Chengze entrusted Tianjin Jiayuankaichuang to perform construction for auxiliary heat supply equipment for Houtai Lot G Project.

On 1 February 2024, Tianjin Chengze entered into the Entrustment Agreement for Auxiliary Reclaimed Water Networks of New Residential and Public Housing in Tianjin ("Reclaimed Water Networks Agreement") with Water Recycling Company, pursuant to which, Tianjin Chengze entrusted Water Recycling Company to perform construction for auxiliary reclaimed water equipment within the planned red line of Phases I, II and III (Zexi Park) of the Houtai Lot G Project.

IMPLICATIONS OF THE LISTING RULES

Tianjin Chengze is an indirect subsidiary of Tianjin Infrastructure Construction, the ultimate controlling company of the Company. Therefore, pursuant to the Listing Rules, Tianjin Chengze, being an associate of Tianjin Infrastructure Construction, is a connected person of the Company. According to the Listing Rules, the transactions contemplated under the Agreements constitute a connected transaction of the Company.

Due to the similar nature of the transactions contemplated under the Agreements, these transactions shall be aggregated according to Rule 14A.81 of the Listing Rules. As all applicable ratios of the Reclaimed Water Networks Agreement on a standalone basis are less than 0.1%, the transactions contemplated under the Reclaimed Water Networks Agreement are deemed to be fully-exempt connected transactions under Chapter 14A of the Listing Rules. Therefore, the Reclaimed Water Networks Agreement is exempted from reporting and announcement requirements. However, when aggregated, one or more applicable ratios of the Agreements exceed 0.1% but are less than 5%, therefore, the Agreements are only subject to reporting and announcement requirements, but are exempted from the independent Shareholders' approval requirement under Chapter 14A of the Listing Rules.

INTRODUCTION

The Board is pleased to announce that on 14 March 2024, the Board has considered and approved the Auxiliary Heat Supply Contract for Houtai Lot G Project ("**Heat Supply Agreement**"), pursuant to which, Tianjin Chengze entrusted Tianjin Jiayuankaichuang to perform construction for auxiliary heat supply equipment for Houtai Lot G Project.

On 1 February 2024, Tianjin Chengze entered into the Entrustment Agreement for Auxiliary Reclaimed Water Networks of New Residential and Public Housing in Tianjin ("Reclaimed Water Networks Agreement") with Water Recycling Company, pursuant to which, Tianjin Chengze entrusted Water Recycling Company to perform construction for auxiliary reclaimed water equipment within the planned red line of Phases I, II and III (Zexi Park) of the Houtai Lot G Project.

Set out below are the summary of the principal terms of the Agreements:

I. HEAT SUPPLY AGREEMENT

Parties

- (a) Tianjin Jiayuankaichuang (as the entrusted party); and
- (b) Tianjin Chengze (as the entrusting party).

Location of Construction

Site of the Houtai Lot G Project in Zhongbei Town, Xiqing District, Tianjin, east to Biling Garden, south to Xiangyi Road bus terminal, west to Shuixi Park, north to Baoze West Road

Scope of Construction

According to the Heat Supply Agreement, Tianjin Jiayuankaichuang shall provide equipment for heat supply, primary networks and heat exchange station and the installation services of the equipment abovementioned (construction works will be provided up to the upper flange of the water distributor cut-off valve inside the heat exchange station) to the Houtai Lot G Project in Zhongbei Town, Xiqing District, Tianjin, east to Biling Garden, south to Xiangyi Road bus terminal, west to Shuixi Park, north to Baoze West Road. Construction of the heat supply does not include civil engineering, water supply and drainage and electrical auxiliary project of the heat exchange station.

Construction Fees and Payment

According to the Heat Supply Agreement, the construction fee for the heat supply works is RMB4,209,553.2.

Tianjin Chengze will pay the construction fee for the heat supply works according to the following schedule and timeline:

1. Upon the execution of the Heat Supply Agreement, Tianjin Chengze will pay RMB1,262,865.96 by 30 May 2024, representing 30% of the total consideration of the Heat Supply Agreement;

- 2. Within 30 days before Tianjin Jiayuankaichuang commences the construction, Tianjin Chengze will pay RMB1,683,821.28, representing 40% of the total consideration of the Heat Supply Agreement; and
- 3. Within 30 days after obtaining the heat supply professional supporting certificate for commercial housing access procedures, Tianjin Chengze will pay RMB1,262,865.96, representing 30% of the total consideration of the Heat Supply Agreement.

The construction fee of the aforesaid heat supply works was determined by parties after arm's length negotiations with reference to (among others) the current market prices of the same or similar types of auxiliary heat supply fees and heat meters in Tianjin.

II. RECLAIMED WATER NETWORKS AGREEMENT

Parties

- (a) Water Recycling Company (as the entrusted party); and
- (b) Tianjin Chengze (as the entrusting party).

Location of Construction

Phases I, II and III (Zexi Park) of the Houtai Lot G Project in the southeastern side of the intersection of Baoze West Road and Xiangyi Road in Xiqing District, Tianjin

Scope of Construction

According to the Reclaimed Water Networks Agreement, Water Recycling Company shall organise the construction of auxiliary reclaimed water equipment within the planned red line of Phases I, II and III (Zexi Park) of the Houtai Lot G Project in the southeastern side of the intersection of Baoze West Road and Xiangyi Road in Xiqing District, Tianjin.

Construction Fees and Payment

According to the Reclaimed Water Networks Agreement, the fee for auxiliary primary water supply facilities in the reclaimed water area is RMB951,717.69, which is to be settled by Tianjin Chengze to Water Recycling Company on a lump sum basis within 30 days after the execution of the Reclaimed Water Networks Agreement.

The fee of the aforesaid auxiliary primary water supply facilities in the reclaimed water area was determined by the parties after arm's length negotiations with reference to (among others) the "Notice on Standardizing Fees and Charges of Construction Fees for New Residential and Public Housing Reclaimed Water Projects" (Jin Jia Fang Di [2009] No. 36).

REASONS AND BENEFITS FOR ENTERING INTO THE AGREEMENTS

The execution and implementation of the Agreements are in line with the business scope of Tianjin Jiayuankaichuang and Water Recycling Company, thus facilitating the increase in the primary business revenue, the expansion of the market share of the new energy heat supply and the reclaimed water supply, and will have a positive impact on the development of the Company.

The terms of the Agreements are determined by the parties after arm's length negotiation. The Directors (including independent non-executive Directors) are of the view that the terms of the Agreements are entered into in the ordinary and usual course of business of the Group on normal commercial terms, and are fair and reasonable and in the interests of the Company and its Shareholders as a whole.

INFORMATION OF THE COMPANY, TIANJIN INFRASTRUCTURE CONSTRUCTION, WATER RECYCLING COMPANY, TIANJIN JIAYUANKAICHUANG AND TIANJIN CHENGZE

The Company is principally engaged in the investment, construction, design, management, operation, technical consultation and auxiliary services of treatment facilities of sewage water, tap water and other types of water; design, construction, management, building and operation management of municipal infrastructures; license operation, technical consultation and auxiliary services of Southeastern Half Ring Urban Road of the Middle Ring of Tianjin; development and operation of environmental protection technology and products; leasing of self-owned properties, etc. Tianjin Infrastructure Construction is the ultimate controlling company of the Company and the sole shareholder of TMICL (a controlling shareholder of the Company), holding 100% equity interest in TMICL.

Tianjin Infrastructure Construction is principally engaged in the investment in river comprehensive development and renovation, subway trains, urban roads and bridges, underground pipeline networks, urban environment infrastructures with self-owned funds; investment planning; corporate management consultancy; market construction development services; leasing of self-owned properties; leasing of infrastructures and development and operation of utilities; construction investment consultation. As at the date of this announcement, the ultimate beneficial owner of Tianjin Infrastructure Construction is Tianjin SASAC.

Water Recycling Company is a direct wholly-owned subsidiary of the Company. Its business scope includes the construction and operation of urban water supply, drainage, sewage treatment and recycled water utilization projects.

Tianjin Jiayuankaichuang is a direct wholly-owned subsidiary of the Company. Its business scope includes heat supply services; research and development of new energy technologies; technical services, technology development, technical consultation, technology exchange, technology transfer, technology promotion; property management and cold supply services.

Tianjin Chengze is an indirect subsidiary of Tianjin Infrastructure Construction, the ultimate controlling company of the Company. Its business scope includes construction projects, real estate development and operations, electrical installation services and interior decoration for residential properties. Its general projects include marketing planning, non-residential real estate leasing, housing leasing, property valuation services, property management, landscape project construction and project management services.

IMPLICATIONS OF THE LISTING RULES

As mentioned above, Tianjin Chengze is an indirect subsidiary of Tianjin Infrastructure Construction, the ultimate controlling company of the Company. Therefore, pursuant to the Listing Rules, Tianjin Chengze, being an associate of Tianjin Infrastructure Construction, is a connected person of the Company. According to the Listing Rules, the transactions contemplated under the Agreements constitute a connected transaction of the Company.

Due to the similar nature of the transactions contemplated under the Agreements, these transactions shall be aggregated according to Rule 14A.81 of the Listing Rules. As all applicable ratios of the Reclaimed Water Networks Agreement on a standalone basis are less than 0.1%, the transactions contemplated under the Reclaimed Water Networks Agreement are deemed to be fully-exempt connected transactions under Chapter 14A of the Listing Rules.
