The board (the "Board") of directors (the "Directors") of the Company wishes to inform the shareholders and potential investors of the Company that based on the latest unaudited consolidated management accounts of the Group for the year ended 31 December 2023 and other information currently available to the Board, the Group is expected to record a net profit attributable to equity holders of the Company ranging from approximately RMB0.8 billion to RMB1 billion for the year ended 31 December 2023 ("FY2023"), as compared to a net profit attributable to equity holders of the Company of approximately RMB0.2807 billion for the year ended 31 December 2022 ("FY2022"). The anticipated year-on-year change of net profit of FY2023 is mainly attributable to (i) the gain recorded from the Company's disposal of its equity interests in and the assets of a subsidiary; (ii) reduced net exchange losses as a result of foreign exchange fluctuation; (iii) the increase in impairment of assets of the subsidiaries of the Company; and (iv) the contraction of the property development business as a result of the industry downturn.
