Remarks: The Unlisted Shares include domestic shares and unlisted foreign shares of the Company.

Reference is made to the announcements of the Company dated 11 March 2024, 15 March 2024 and 25 March 2024. As at 29 February 2024, the opening balance of the total number of issued shares of the Company was 417,167,290 which comprised 131,590,632 H Shares and 285,576,658 Unlisted Shares. Following the completion of the Conversion and Listing, the H Shares increased by 178,715,577 Shares, while the Unlisted Shares decreased by 178,715,577 Shares. The total number of issued shares of the Company after the Conversion and Listing remains unchanged.

9. *Items (i) to (viii) are suggested forms of confirmation which may be amended to meet individual cases.*

10. *“Identical” means in this context:*

- *the securities are of the same nominal value with the same amount called up or paid up;*
- *they are entitled to dividend/interest at the same rate and for the same period, so that at the next ensuing distribution, the dividend/interest payable per unit will amount to exactly the same sum (gross and net); and*
- *they carry the same rights as to unrestricted transfer, attendance and voting at meetings and rank pari passu in all other respects.*
