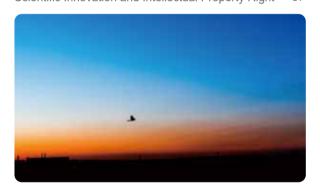

About the Report

Report Description

March 2021

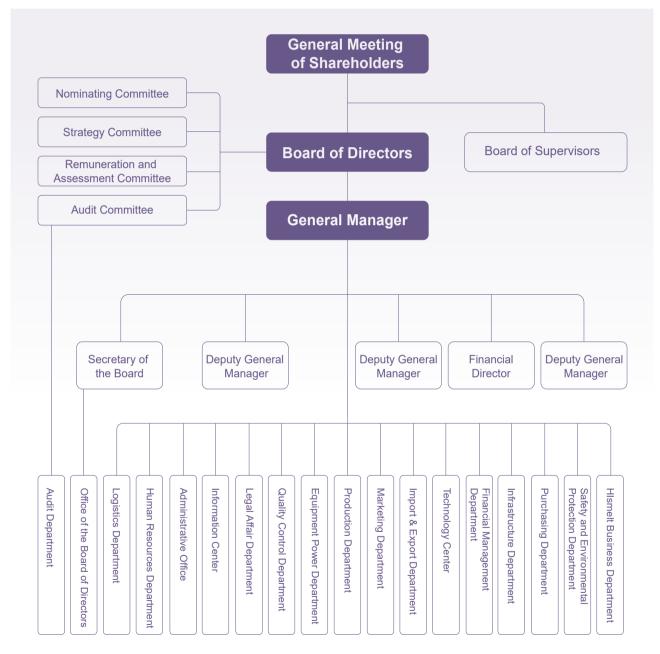
Steady and Normative Operation

The minutes of each session of the board of directors were recorded in a true, accurate and integral form, and it was ensured that the conferences' resolutions are accurate enough and disclosed promptly.

The Company thinks highly on the construction of the board of directors and continuously promote the independence. specialty and diversity of the board of directors. The Company's board of directors consists of 9 directors, among which there are 3 independent directors and 1 female director.

Board of Supervisors

The Company's board of supervisors consists of 3 supervisors, including 2 supervisors selected by the general meeting and 1 supervisor acting as the staff representative, who is selected by the conference of staff representatives in a democratic form.

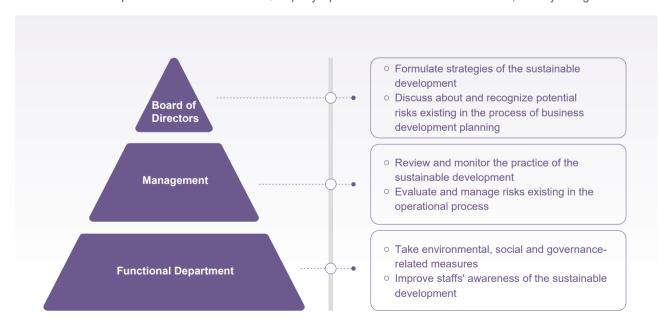

Recognition of Substantial Topic

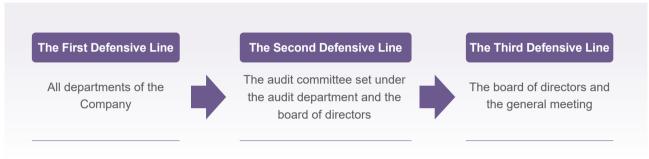
The Company's system of legal consultation is established and completed.

The system of the power balance between important positions is established, and separation of incompatible duties is clearly stipulated.

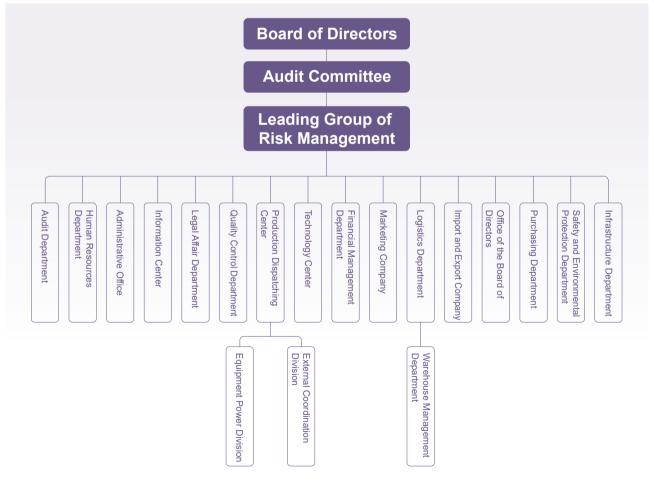

Risk Management

The Company attached importance to risk management, established a normative and effective system of risk control, improve its capacity of risk prevention and ensured the Company's safe and stable operation. According to relevant provisions of the *Company Law, Accounting Law* and other laws, regulations and regulatory documents, the company formulated the *System of Risk Management* to ensure the Company's healthy and sustainable development with operational compliance and realize a long-thriving foundation of the Company. At the same time, with the leadership of the board of directors, the Company constructed "three defensive lines" of risk management and formed the organizational structure of the Company's risk management.

Anti-Fraud

The Company strictly observed laws and regulations, such as the Contract Law, Company Law, Anti-monopoly Law, Anti-unfair Competition Law, etc., combined the Company's actual situation to formulate the Rules of Anti-Fraud Management, strengthen internal control, reduce the Company's risks and standardize operational behavior. The Company specially established an anti-fraud audit committee, with the general principal served by the president and members consisting of the members of the office commission of managers and the audit department, which acts as the permanent organization of the anti-fraud audit committee. The anti-fraud audit committee is responsible for the board of directors and accepts the supervision of the board of supervisors.

During the Report Period,

The Company didn't find any behavior of corruptions, briberies, etc. or fraud events in the routine audits.

The management of the Company took the anti-fraud work as a part of daily management work, actively support the daily work of the permanent anti-fraud organization and provided sufficient guarantees in terms of the budget, staff allocation and working condition preparation. The Company kept maintaining the smooth channel of employees' reports, organized the conferences of staff representatives on a regular basis, convened an anti-fraud situation report meeting in each year, publicized and practiced anti-fraud and anti-corruption knowledge for one time per year and timely found the corrupt events of frauds, briberies, etc. that may happen inside the Company. At the same time, the Company also established complete systems of informer protection and report channels.

Provisions of Informer Protection

The Company strictly keeps the informer's name, working department, home address and other related information, as well as the reported content confidential. Liable people who violate the stipulation of confidentiality, depending on the specific situation, shall be punished with the penalty of 1,000 yuan or termination of the labor contract.

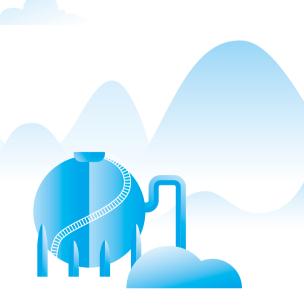

The technique of HIsmelt non-blast furnace ironmaking gets rid of the reliance of traditional blast furnace ironmaking on the resources of coking coal, realizes simplification of the whole process of ironmaking and effectively reduces carbon emission, with important significance for the green development, transformation and upgrade of China's iron industry.

At present, the Company's high-end casting and forging products developed on the basis of the existing HIsmelt smelting reduction technology have been widely applied to the industry of equipment manufacture in the fields of nuclear power, wind power, high-end machine tools, etc.

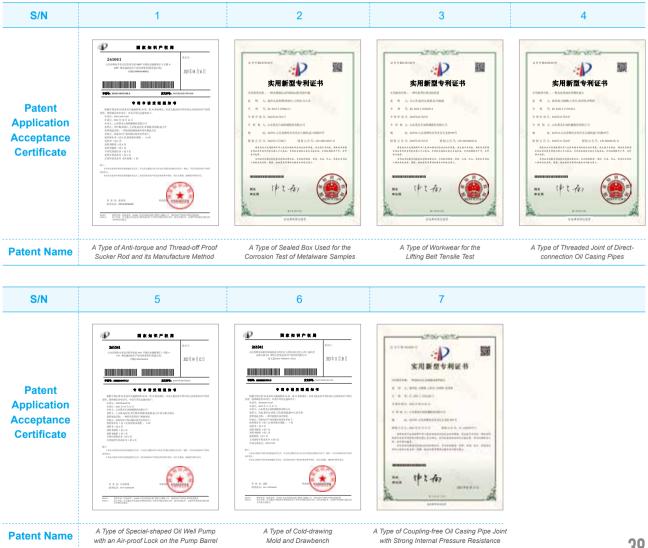

Exhaust Gas Management

The Company strictly followed the requirements of the Law of Prevention and Control of Atmospheric Pollution and other laws and regulations and intensively promoted ultra-low emission transformation to strengthen the comprehensive governance of air pollution. The Company set multiple sets of exhaust gas governance facilities, including SCR denitration, alkali process desulfurization, activated carbon adsorption, photo-oxygen catalysis, etc., as well as four sets of online monitoring facilities to monitor the emission of pollutants in a real-time form and ensure that the emission goal determined by the Company can be achieved. The Company also formulated emergency plans for the weathers with heavy pollution and conducted emission reduction activities corresponding to the response level when governmental authorities issued early warning of the weathers with heavy pollution.

Waste Management

Shandong Molong strengthened the regulation of emission reduction from the source, continuously optimized measures of solid and dangerous waste management, formulated the Management System of Solid and Dangerous Waste Management and other internal documents to further standardize the treatment process of general industrial solid wastes and dangerous wastes. Sunshine purchase

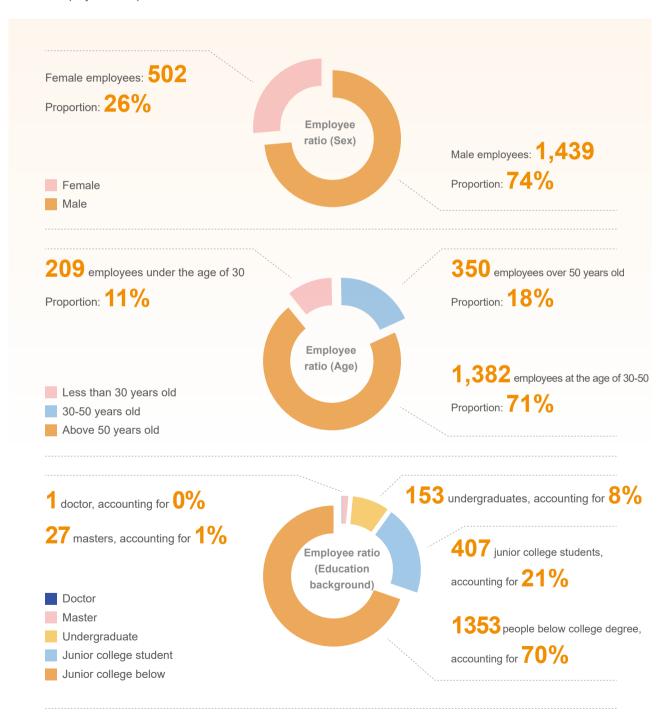
Protection of women's rights and interests

Labor union assistance

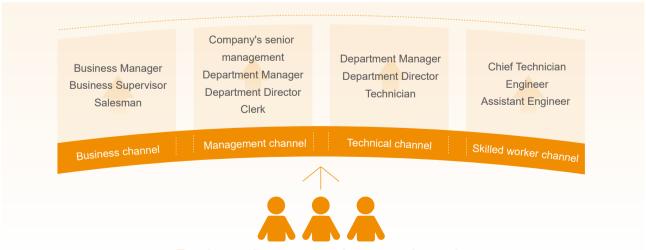

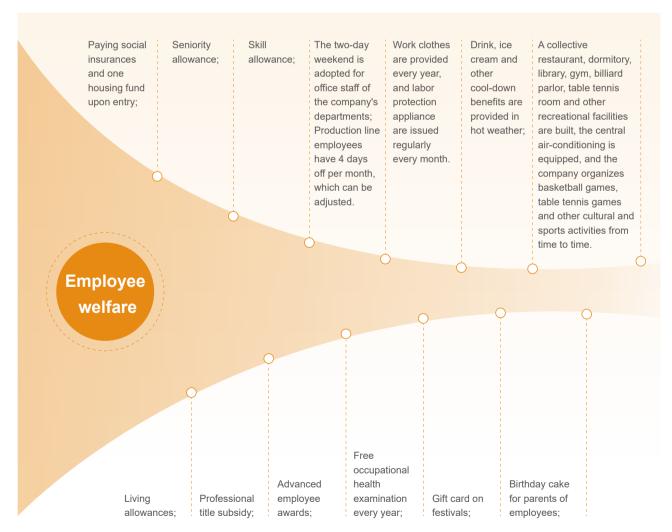
