Remarks:

(1) The translations between United States dollar and Hong Kong dollar amounts at US\$1= HK\$7.82, being the exchange rate prevailing on 29 March 2024. 10. *“Identical” means in this context:*

- *the securities are of the same nominal value with the same amount called up or paid up;*
- *they are entitled to dividend/interest at the same rate and for the same period, so that at the next ensuing distribution, the dividend/interest payable per unit will amount to exactly the same sum (gross and net); and*
- *they carry the same rights as to unrestricted transfer, attendance and voting at meetings and rank pari passu in all other respects.*
