New Arrangements on Dissemination of Corporate Communications

INTRODUCTION

Pursuant to new Rule 2.07A¹ of the Rules (the "**Listing Rules**") Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the "**Stock Exchange**") and the bye-laws (the "**Bye-laws**") of Blue River Holdings Limited (the "**Company**"), the Company will disseminate the future corporate communications of the Company (the "**Corporate Communications**"²) to its Shareholders³ electronically and only send Corporate Communications in printed form to the Shareholders upon request.

ARRANGEMENTS

1. Actionable Corporate Communications⁴

The Company will send the Actionable Corporate Communications to Shareholders individually in electronic form by email. If the Company does not possess the email address of a Shareholder or the email address provided is not functional⁵, the Company will send the Actionable Corporate Communications in printed form together with a request form for soliciting the Shareholder's functional email address to facilitate electronic dissemination of Actionable Corporate Communications in the future.

2. Corporate Communications

The Company will make the Corporate Communications available on its website (<u>www.blueriverholdings.com.hk</u>) and the Stock Exchange's website (<u>www.hkexnews.hk</u>).

In accordance with the existing Bye-laws, a notice of publication of the Website Version⁶ of Corporate Communications, in both English and Chinese, will be sent by the Company to Shareholders by email or by post (only if the Company does not possess the functional email address of a Shareholder) on the publication date of the Corporate Communications. The Company will propose necessary amendments to its Bye-laws becoming effective at the forthcoming annual general meeting of the Company, and if approved and adopted, cease sending such notice of publication of the Corporate Communication to its Shareholders in future, subject to compliance with the Bye-laws as

amended from time to time and the Listing Rules. The Company will make further announcement(s) in respect of the proposed amendments of the Bye-laws as and when appropriate.

3. Provision of Shareholder's Email Address to the Company

In support of electronic communication by email, the Company recommends its Shareholders to complete the online form by scanning above QR Code which is valid by 2 June 2024 (2 months after the despatch date). Should the Shareholders, if for any reason, have difficulty in gaining access to the online form, they may provide the Company with their email address at any time in future by reasonable notice in writing to the Company's branch share registrar and transfer office in Hong Kong, Tricor Secretaries Limited, at 17/F, Far East Finance Centre, 16 Harcourt Road, Hong Kong or by email to <u>498-ecom@hk.tricorglobal.com</u>.

It is the responsibility of the Shareholders to provide email address that is functional. If the Company does not possess the email address of a Shareholder or the email address provided is not functional, the Company will act according to the above arrangements. The Company will be considered to have complied with the Listing Rules if it sends Actionable Corporate Communications to the email address provided by a Shareholder without receiving any "non-delivery message".

4. Request for printed copy of Corporate Communications and Actionable Corporate Communications

For those Shareholders who wish to receive a printed version of all future Corporate Communications and Actionable Corporate Communications or, if for any reason, have difficulty in gaining access to the Company's website, the Company will, upon receipt of request in writing by the Shareholders to the Company's branch share registrar and transfer office in Hong Kong, Tricor Secretaries Limited, at 17/F, Far East Finance Centre, 16 Harcourt Road, Hong Kong or by email to <u>498-ecom@hk.tricorglobal.com</u>, send future Corporate Communications and/or the relevant Actionable Corporate Communications (as the case may be) to such Shareholders in printed form free of charge. If the Company does not receive any request, Shareholders will be considered to have agreed to the dissemination of Corporate Communications and Actionable Corporate Communications in the manner described above which fulfils the Company's obligation to send the Corporate Communications and Actionable Corporate Communications to the Shareholders.
