## **Electronic Dissemination of Corporate Communications**

If the Company does not receive the duly completed Reply Form from you (or another response from you indicating that you object to the Email Option) by 19 April 2024, you will be implied to consent, until you inform the Company otherwise by reasonable notice in writing to the Hong Kong Share Registrar at the above address or by email to <u>1164-corpcomm@unionregistrars.com.hk</u>, to have elected to receive printed notification letter of the publication of the Company's Specific Corporate Communications. Pursuant to the Articles of Association of the Company, the Company will send notification(s) to you in respect of the Company's Specific Corporate Communications.

2) Other Corporate Communications

The Company will make the Other Corporate Communications available on the Websites.

The Company will not send a notice of publication of the Other Corporate Communications to its Shareholders. The Shareholders are encouraged to proactively monitor the availability of future Other Corporate Communications on the Websites.
