ANNOUNCEMENT POWER GENERATION FOR MARCH 2024

The board of directors (the "Board") of China Longyuan Power Group Corporation Limited* (the "Company") announces that, according to the Company's preliminary statistics, the power generation of the Company and its subsidiaries (the "Group") for March 2024 on a consolidated basis amounted to 7,758,084 MWh, representing a year-on-year increase of 13.34% as compared with the corresponding period of 2023. In particular, the wind power generation registered an increase of 5.12%, the coal-fired power generation registered an increase of 17.74%, and other renewable energy power generation of the Group for 2024 amounted to 21,225,249 MWh, representing a year-on-year increase of 8.27% as compared with the corresponding period of 2023. In particular, the wind power generation registered an increase of 1.37%, the coal-fired power generation registered an increase of 11.30%, and other renewable energy power generation registered an increase of 233.33%.
