1. The MoM increase in total sales volume of camera module products was mainly attributable to the seasonal sales rebound after the Chinese New Year holiday and customers' project cycle. The significant YoY increase in the sales volume of camera modules for other fields was mainly attributable to the good development of the Group's business in automotive camera module products and the camera module products for Internet of Things (IoT).
2. The MoM increase in total sales volume of fingerprint recognition module products was mainly attributable to the seasonal sales rebound after the Chinese New Year holiday and customers' project cycle.
